

This stakeholder workshop focuses on space tourism, one of the International Institute of Space Commerce (IISC)'s areas of interest, and it is compliant with the aim of the Institute: to broaden the professional perspective and personal understanding of all those involved in the study, formulation, execution, and management of Space Commerce.

The Space Tourism debate continues as both interest and concern grows at a worldwide level. Space Tourism offers not only entertainment, but other benefits such as access to alternative airspace routes which offer shorter flying times, and opportunities for technology creation and innovation.

The implementation of Space Tourism raises technical, commercial and regulatory issues, as well as economic and political challenges, the full scope of which warrants a systematic and complete approach, shared by all stakeholders.

This workshop has the ambitious goal to focus attention on the insurance of all aspects of Space Tourism. The first panel provides a comprehensive overview of the risks arising from Space Tourism activities. The second panel covers solutions in terms of liability regime, licensing policy and insurance mechanisms.

The conclusions of the workshop will be exploited to generate a pool of recommendations to encourage policymakers and stakeholders in the aerospace industry, as well as the general public, to think critically about the potential role of Space Tourism in generating added value and enhancing the global credibility of space.
